**RESOLUTION FILLING VACANCY IN OFFICE OF COUNTY COMMISSIONER
SEAT C UNTIL SUCH OFFICE IS FILLED AT THE 2018 GENERAL ELECTION**

WHEREAS, a vacancy exists in the Office of County Commissioner Seat C effective May 11, 2018; and

WHEREAS, when such vacancy exists, pursuant 10 ILCS 5/25-11, the Board of County Commissioners of the County of Union, Illinois shall declare that a vacancy exists and the vacancy shall be filled within 60 days by appointment of the Chairman of the Board of County Commissioners of the County of Union, Illinois with the advice and consent of the Board of County Commissioners of the County of Union, Illinois; and

WHEREAS, pursuant 10 ILCS 5/25-11, the appointee shall be a member of the same political party as the person he succeeds was at the time of his election and shall be otherwise eligible to serve; and

WHEREAS, the person previously holding the Office of County Commissioner Seat C was a member of the Republican Party; and

WHEREAS, more than 28 months remain in the current term of the Office of County Commissioner Seat C; and

WHEREAS, pursuant 10 ILCS 5/7-11.1 and 10 ILCS 5/25-11, such appointment shall be until the next general election at which time the vacated office shall be filled by election for the remainder of the term.

WHEREAS, Board of County Commissioners of the County of Union, Illinois have determined that David Gould is a member of the Republican Party and should be appointed to fill the Office of County Commissioner Seat C until a successor is elected at the 2018 General Election and assumes the Office of County Commissioner Seat C as provided by law.

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the County of Union, Illinois as follows:

Section 1: David Gould is appointed to the Office of County Commissioner Seat C until a successor is elected at the 2018 General Election and assumes the Office of County Commissioner Seat C as provided by law.

Section 2: The Union County Clerk shall transmit a certified copy of this Resolution to the Illinois Secretary of State and shall take all other actions as required by law regarding this Resolution.
